The **Seekonk Housing Authority**, the Awarding Authority, invites sealed bids from **General Contractors** for the **705-1A Roof Replacement, #265057** in Seekonk, Massachusetts, in accordance with the documents prepared by **Rowse Architects**.

The Project consists of: Removal of the existing underlayment, flashing, roofing, gutters & downspouts, replacement of deteriorated roof sheathing and the installation of new underlayment, drip edge, flashing, new 50 year asphalt shingles and new gutters & downspouts.

The work is estimated to cost **\$44,400**.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.
